Mr. Holmes made a motion to appoint Ms. Drummond as Delegate to the State Convention. Mr. Orlow seconded. The vote was unanimous.

Mr. Orlow made a motion to appoint John Nagel a representative to the East Whiteland Volunteer Fire Company. Ms. Drummond seconded and the vote was unanimous.

#### APPOINTMENT TO BOARDS AND COMMISSIONS

##### **Environmental Advisory Council**

## **Resolutions**

Resolution No. 3 -2017 Emergency Services – Mr. Orlow made a motion to adopt Resolution No. 3-2016 and the Appendix to Resolution No. 3-2015 appointing East Whiteland Fire Company, Malvern Fire Company to provide fire protection, ambulance and rescue service; East Whiteland Police Department is to provide police service; and Medic 4 which is operated by the Malvern Fire Company is to provide primary advance life support coverage. Ms. Drummond seconded and the vote was unanimous.

Resolution No. 4-2017 Local Services (LST) Tax Collector –Mr. Orlow made a motion to adopt Resolution No. 4-2016 appointing Keystone Collections Group of Pennsylvania to collect the East Whiteland Local Services Tax. Ms. Drummond seconded and the vote was unanimous.

Resolution No. 5-2017 Appointment of Earned Income Tax Collector – Mr. Orlow made a motion to adopt Resolution No. 5-2016 appointing Keystone Collections Group of Pennsylvania to collect the Earned Income Tax. Ms. Drummond seconded and the vote was unanimous

Resolution No. 6-2017 Appointment to Vacancy Board – Mr. Orlow made a motion to reappoint Victoria Damiani to the Vacancy Board for a one year term ending January 3, 2017. Ms. Drummond seconded and the vote was unanimous.

Resolution No. 7-2017 Dedication of Roads – Mr. Orlow made a motion to adopt Resolution No. 7-2016 specifying that the Township will accept roads for dedication only between April 1, 2016 and July 1, 2016. Ms. Drummond seconded and the vote was unanimous.

Resolution No. 8-2017 – Fee Schedule – Ms. Drummond made a motion to adopt Resolution No. 8-2016 whereby the Township establishes a consolidated fee schedule for services provided. Mr. Orlow seconded and the vote was unanimous.

## **Banking**

Banks as Depositories for Township Funds – Mr. Orlow made a motion to authorize Penn Liberty Bank, First Niagara Bank, Meridian Bank, and Stifel Investment Services as depositories for Township Funds. Ms. Drummond seconded and the vote was unanimous.

Establish Amount of Surety Bond – Mr. Orlow made a motion to establish the amount of the Surety Bond for the Treasurer in the amount of \$3,000,000 and Assistant Treasurer at \$2,500,000. Ms. Drummond seconded and the vote was unanimous.

7. The Municipal Authority will meet at 7:00 pm on the third Thursday of the following months: January, April, July and October
